Performance and Wellness Program Grant - Year 2 Frequently Asked Questions

- 1. When can my agency apply for this grant? The grant application period is from April 1, 2025 to June 30, 2025. The application will be posted on the NCACP website.
- 2. If my agency applied and received the grant in Year 1, is my agency eligible for the grant in Year 2?
 <u>Yes.</u> An agency that received the grant in Year 1 has priority to receive the grant in Year 2, though the agency must still submit an application. The grant applications will be reviewed by the grant committee in the order in which they are received.
- 3. If my agency did not apply or receive the grant in Year 1, can we still apply for the grant in Year 2?
 Yes. All agencies are encouraged to apply for the grant in Year 2. Even if all the agencies that received the grant in Year 1 apply and receive the grant in Year 2, there will still be funds available for additional agencies, though we do recommend you apply as soon as possible because funds are expected to be exhausted.
- 4. Are there additional requirements for those agencies that received the grant in Year 1, when applying for the grant in Year 2? Yes. If any question in the Year 2 application under "Section 1: Primary Requirements for Applicants" was answered in the Year 1 application as "Commit to...." the agency must advise the progress

they made in Year 1. <u>Example:</u> Your agency checked the box "Commit to establishing a Chaplain Program". Your agency must indicate what progress was made in establishing this program in the Year 2 application.

- 5. When will my agency be notified if they are awarded the grant? The grant committee will begin reviewing applications before the applications close on June 30, 2025, though agencies will not be notified of being awarded the grant until after the closing of applications. The first award notifications should go out within the first two weeks of July, 2025.
- 6. If my agency was awarded the grant in Year 1, must we submit the application for the same program as Year 1?
 <u>No.</u> Your agency may choose to use another company or develop another program. If a change is made, it must fall within the original guidelines of the Performance and Wellness Program.
- 7. Are there any deadlines for receiving the grant award in Year 2? <u>Yes.</u>
 - A. The application for Year 2 must be completed and submitted by June 30, 2025.
 - B. When an agency has been notified they have been awarded the grant they will have <u>30 days</u> to sign and return the <u>Acceptance</u> <u>Agreement</u> to the NCACP Performance and Wellness Grant Manager.
 - C. When an agency has been notified they have been awarded the grant, they will have <u>90 days</u> to request reimbursement of funds awarded.
